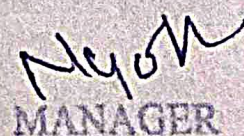

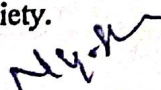

5. That the society has no profit motive in any form. It is running the Educational institutions purely on service motive and basically for the education of the children of the weaker section of the society.

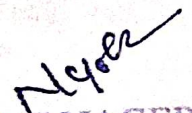

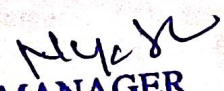
